

EXPLANATORY NOTES

NOTICE REGARDING OTHER ORDERS OR PROCEEDINGS (section 6 of the *Directive relative au Tribunal unifié de la famille*)

You must produce this notice if **you are the subject** of:

- a) a civil protection order under article 515.1 and following of the *Code of Civil Procedure* or an application relating to such an order (e.g., an order not to go to a location or contact a person);
- b) an order, an application, an agreement or a decision relating to youth protection; or
- c) an order, an indictment, an undertaking or a recognizance relating to a criminal matter (e.g., prohibition from contact or a recognizance under section 810 of the *Criminal Code*).

TYPES OF FORMS

- Dynamic PDF:

After completing the form, you can print it on letter-size paper, i.e., 8.5 inches by 11 inches (215.9 mm by 279.4 mm).

- Paper:

If you complete the form by hand, please write legibly in block letters.

PROCEDURE

Once the form is completed, keep a copy for your files.

If you are the subject of a situation referred to in paragraph (a) or (c) and the other party or a child concerned by the proceeding is involved, **you must include** a copy of the order, undertaking, recognizance, indictment or application for a protection order.

If you are the subject of the situation referred to in paragraph (b) and a child concerned by the proceeding is involved, **you must include** a copy of the order, application, agreement or decision.

Additionally, if the situation changes in the course of the proceedings, you must file a new notice with the court office and, if the other party or a child concerned by the proceeding is involved, include the documents that show that fact.
